1. Tendulkar Middlesex Global Academy (TMGA) Camps operate under Tendulkar Middlesex Global Academy Ltd
2. All applications for participants attending the TMGA Camps shall be made using the appropriate booking form. Booking form can be found at: www.camptendulkarmga.in/book-here
3. By making payment and clicking that you agree to the terms and conditions on the online form, you hereby agree, understand and abide by these terms and conditions.
4. Following receipt of your booking form and payment, Tendulkar Middlesex Global Academy will send you an email to confirm your booking. We have restricted number of places for each camp. If you have signed up after the camp has been fully subscribed, we will place you on a waiting list operated on a first come first served basis.
5. To secure your place, you must complete the 2 stage booking process. Your place will be confirmed after you have completed the booking form, with essential information about the player attending which is required for camp organisation (part 1) AND once you have successfully completed the payment process held on Bayside Sports payment page (Part 2).
6. To apply for a cancellation/refund, please email enquiries@tendulkarmga.com with the name of the child and the course dates you wish to cancel. A member of staff from Tendulkar Middlesex Global Academy will contact you to confirm the cancellation and organise a refund, where applicable. A cooling off period is provided within 48 hours of form completion.

Cancellations are subject to the following terms:

- Two weeks prior to camp, 14 days before the start of the camp you have signed up for – 50% refund
- Less than Two weeks prior to camp, 13 days or less, prior to the start of the camp you have signed up for - No refund
- Any additional refunds will be at the discretion of TMGA.

7. We reserve the right to cancel at any time under extenuating circumstances. No credit days will be issued however any refunds will be at the discretion of TMGA.
8. Injury/Illness*: In the case of any participant missing sessions due to injury or sickness, refunds a maximum of 10% of the amount missed will be granted.

* Please note that refunds or transfers to be issued due to injury or sickness need to be supported by an official doctor's certificate confirming that the participants physical health is no longer suitable to take part in the remaining sessions.
9. TMGA reserves the right to modify a programme due to adverse weather conditions, or other extenuating circumstances.

11. By making payment and completing the booking form, you confirm that you have the parent responsibility or legal guardianship of the child registered within the booking form (where required by law for people under the age of 18):
 - You have read and accept all of our terms and conditions.
 - You accept that the player will need to take their own responsibility for administering medication. In the event of a medical emergency, care will be provided by TMGA trained first aiders or medical professionals where appropriate.
 - Medical consent will be explicitly required and will be requested on the consent forms that need to be returned, signed, before the start of the camp.
 - We have the ability to refuse entry and offer a full refund for players who we are unable to be cared for appropriately through the camp experience by TMGA.
12. You consent that we may call upon emergency medical advice for your child if an incident requires it.
13. You accept that there is an inherent risk of injury in our cricket programme.
14. You consent to trained first aid personnel caring for your child in the event of an accident or medical emergency.
15. All participants are required to bring enough of their own food and drink with refillable bottle to provide energy throughout each day. **No nuts allowed in own food in any form.**
16. All information contained on completed booking forms will be treated in confidence by TMGA in accordance with the Data Protection Act 1998 and GDPR compliance 2018.

18. All bookings are personal to the player named on the form and are non-transferrable. Price is inclusive of GST.
19. If you are eligible for more than one discount code, please apply the code with the biggest saving to you. As only one discount code is accepted per purchase.
20. High quality players - to be eligible for high quality player discount, you must have attended a TMGA camp previously and be one our list of high quality players. Players who are eligible for this discount, will be contacted directly over email or telephone.
21. TMGA reserves the right to change camp attendance fees and apply bursary reductions as appropriate. Wherever possible reasonable notice will be given. Bursary places are granted at TMGA discretion.
22. Loss, Damage and Personal Injury. The participant will be fully responsible for all personal property brought onto the premises and shall indemnify TMGA from any loss or damage to property including property of TMGA, which occurs during the camp.
23. TMGA provide Limited Liability with Medical Support to each player. First aid will be provided by qualified practitioners while a player is on site in the event of an injury or accident and TMGA will look after the player's safety and immediate wellbeing while in TMGA care. TMGA will arrange transportation to a local hospital if required, with appropriate communication with parents. Upon arrival and admission to hospital care, parents will be requested to make decision regarding ongoing care. Any additional treatment costs will be covered by the parent or legal guardians of participant injured.
24. Policies are shared online, and forwarded to the participant's parents/legal guardians, and Consent will be requested after the process has been completed. Consent needs to be returned in hard copies, signed by parent/legal guardian and dated, before TMGA accept responsibility of the player on the first morning. Players who arrive without a signed hard copy consent form, will not be able to participate and no refund will be given.
25. You will be asked to signed an explicit consent form for the use of imagery. Content will be to adhere to the photography and videoing policy to use the image in one or more of the following ways:
 - Publication in prospectuses and other promotional material.
